Platform

- 1. What do you believe should be the **top 5 priorities** for Council? (*in order of priority*)

 MSP Control I will co-lead an initiative with the Mayor to establish Council support and agreement to conduct a complete review of all aspects of the MSP, to become aware of all of the details which led to its current status and the implications of this. I will then use the results of this, with Council, to communicate with the taxpayers and gain support to develop an initiative to approach the Provincial Government seeking reversal of the special rule, for the main reason that it contravenes the Government's Places To Grow legislation. If a complete reversal is not possible, for agreed upon reasons, I will lead Council in developing an ongoing strategy to significantly reduce the scope and timing of the development, to bring it in line with acceptable growth targets and plans for Springwater. I will ensure that the whole process of this involves public information, input and support. There will be no more in camera meetings and lack of or late or minimal, evasive communication with other members of Council and the public regarding this whole matter.
- 2. **Fiscal and operational improvement** I will form and lead a Finance Committee to streamline and improve the budgeting process, financial reporting , finding cost efficiencies, lower or eliminate tax increases and help provide better service to constituents. My CA and Trustee training and business and board experience will assist with this initiative.
- 3. **Governance** I will create leadership to establish better communication, trust, honesty, accountability and cohesiveness within Council.
- 4. **Community initiatives** I will work with the Springwater communities to identify, prioritize and develop strategies to progress initiatives important to them.
- 5. **Environmental plan** I will encourage Council to develop a committee, including external qualified members, which will use the upcoming environmental assessment resulting in the MSP process, in conjunction with other studies already completed or necessary to complete, to develop an overall environmental plan for the Township. Input will be received in establishing this from environmental groups in the Township.

What steps do you intend to take or recommend to council in order to achieve NUMBER 1?

- Work with the Mayor and Councillors to develop strategy detail and timing;
- Conduct a meeting of the taxpayers to receive input and support;
- Obtain Council approval to proceed with the initiative;

- Mayor and Deputy Mayor and interested Councillors form a working group to study details and develop a strategy to approach the Government;
- Approach the Government to negotiate a reversal or significant revision to the project.
- Report back to Council and the taxpayers and finalize next steps based on the negotiations.
